# **DCR Flood Hazard Management Program News**

Imagine a Massachusetts where our floodplains aren't just resilient, but healthy and thriving – a place where nature and communities flourish, even when the rains come. The Massachusetts Statewide Floodplain Management Framework is a collaborative network of entities concerned with coordinated flood loss reduction though strategies including flood hazard mitigation actions, restoration and protection of our floodplains, and examination of practices for improved stormwater management. In 2024, key agencies across the state came together to develop a shared future vision, mission, and goals. Inspired by initiatives such as the Texas Flood Plan, the Natural Floodplain Functions Alliance, and Floodplains by Design which began in Washington State, we are kicking off the next phase of work this spring, including an Integrated Floodplain Management audit. Integrated Floodplain Management (IFM) is a multi-disciplinary approach to managing floodplains that brings together multiple stakeholders, encourages agency collaboration, and seeks to achieve multiple floodplain benefits for people and nature. The audit will review MA's floodplain management and river/stream management policies and processes to determine how ready state agencies are for a statewide IFM strategy. Simultaneously, a facilitator has been engaged to guide the collaborative in refining its goals and objectives, building alignment across agencies for future flood and floodplain management planning efforts.

But that's not all! We're also committed to making sure *everyone* is protected from flooding. Our program has partnered with MAPC, Planning Communities, R.E.G. Solutions, and Weston & Sampson to conduct a statewide assessment of Flood Vulnerability in Environmental Justice (EJ) communities. We've been talking with local officials, community leaders, and residents – everyone's voice matters! We've also conducted a statewide flooding survey and compiled existing maps and data from multiple sources giving us a much better picture of where and how floods are impacting vulnerable communities right now. This spring, we're excited to embark on the project's final phase: piloting the co-design of flood mitigation solutions in Brockton, Everett, and West Springfield. Want to hear more about this important work? Reach out to our office or come to our presentation at ASFPM in New Orleans this May! We'd love to share our progress and connect with you.

A significant development from Beacon Hill: Section 125 of the November 2024 Climate Bill establishes a crucial mandate for enhancing flood risk mapping in the Commonwealth. This legislation directs the Secretary of Energy and Environmental Affairs (EEA) to undertake a comprehensive review of existing flood risk mapping resources. This review will serve as the foundation for a subsequent assessment of the need and feasibility of developing additional flood risk mapping resources. The goal is to identify vulnerable areas throughout the Commonwealth with greater precision. Furthermore, the EEA is tasked with formulating recommendations based on these findings. These recommendations will address any legislative or funding requirements necessary to implement enhanced flood risk mapping capabilities. The EEA must submit these recommendations to the legislature by August 18, 2025. This initiative represents a significant step towards improving our understanding of and preparedness for flood risks in Massachusetts.
